FREQUENTLY ASKED QUESTIONS OF Lower Eastern S



What is United Way of the Lower Eastern Shore, and how is it different from United Way Worldwide? UWLES is an independent, local, 501(c)3 non-profit organization established in 1944 in Wicomico County, MD. Our independence allows

us to focus on the needs of the counties we serve (Dorchester, Somerset, Wicomico, and Worcester). UWLES harnesses the power of our community to advance health and well-being, youth opportunity, financial security, and community resiliency for all neiahbors.

We are a member of the United Way Worldwide network, which provides benefits such as cost-saving services and tools, collaborative opportunities, professional development and training, and brand recognition. United Way Worldwide and network members mobilize communities to action so all can thrive, working towards a future where every person in every community can reach their full potential.

Who is the United Way's team comprised of?

UWLES is always governed and guided by a volunteer Board of Directors who represent communities across the Lower Shore. UWLES' Advisory Council extends our outreach and impact with additional community representatives who want to help engage, energize, and elevate our work.

Day-to-day activities such as optimizing and processing donations, managing direct programs and collaborations, volunteer activities, supporting nonprofit partners, and planning special events are handled by a small, professional staff located in the Salisbury office. Where does my contribution go?

- Your gift creates local impact through UWLES' direct services and programs, advocacy, volunteer connections, and investment in local nonprofits.
- Community Impact funds are invested in approved partner agencies and UWLES' direct programs and community initiatives. Annual contributions may be designated to an approved partner agency or direct program (\$50 min. per designation).
- A benefit of United Way Worldwide membership is a reciprocal giving program, allowing donors to direct their gift to other United Ways and those not living locally to donate to us. We also collaborate to help multi-state businesses build successful employee engagement within their local communities.

How does United Way decide how much to distribute to each agency?

UWLES' Community Impact Committee are local volunteers who invest their time and energy to visit with applicants who request operational or program support. Committee members learn about their work and programs and review applications, budgets, outcomes, and efficiencies in meeting local needs. Funding recommendations are approved by the Board of Directors based on annual fundraising and are distributed monthly to approved partners.

What is United Way of the Lower Eastern Shore's administrative rate?

UWLES' administrative rate is 23%, below the long-time national standard of 25-35%. Fortunately, there is a growing awareness for nonprofits to invest more equitably in operational needs to ensure we have the professional workforce, technology, and financial resources to effectively and consistently deliver on our mission and meet expanding community challenges.
